

Food Establishment Licensing Exemptions

Vermont state law (18 V.S.A. 4351) requires that a person obtain a license from the Department of Health to operate a food manufacturing facility, retail food establishment, or other place in which food is prepared and served. There are exemptions from the licensing requirements, but the law at 18 V.S.A. 4358(c) requires that a person claiming a licensing exemption provide documentation concerning their exempt status.

Home Bakery with Annual Sales <\$6500

18 V.S.A. § 4358(b) provides a licensing exemption for an individual manufacturing and selling bakery products from his or her own home kitchen whose average gross retail sales do not exceed \$125.00 per week (or \$6500 per year). Per the definition of "bakery" in 18 V.S.A. §4301, bakery products include "bread, cakes, pies, or other food products made either wholly or partially with flour." If your establishment produces baked goods containing ingredients that require refrigeration or temperature controls, such as meat pies or quiches, then they are not considered bakery products. Your establishment would not qualify for the exemption and you must apply for a home caterer license from the Department of Health. Further, if you prepare or offer meat products for resale to restaurants or stores you may need a license from the Vermont Agency of Agriculture.

Additionally, if your establishment sells food products to restaurants, then you will not qualify for the small home bakery exemption. Food products from unlicensed establishments are not considered an "acceptable source" of food for restaurants per the Health Regulations for Food Service Establishments §5-204; they must be sourced from a licensed food processor.

Claiming an exemption from the licensing requirements does not exempt an establishment from compliance with the Department of Health's food safety and sanitation requirements in the <u>Health Regulations for Food Service</u>

<u>Establishments</u>, nor does the exemption prevent a public health inspector from inspecting your establishment to ensure those requirements are being complied with and investigating any potential public health hazards.

Food Manufacturing Establishment with Annual Sales <\$10,000

18 V.S.A. § 4353 provides an exemption from the Department of Health licensing requirements for food manufacturing establishments that process food for resale and have gross annual sales of less than \$10,000.00.

Additionally, if your establishment sells food products to restaurants, then you will not qualify for the exemption. Food products from unlicensed establishments are not considered an "acceptable source" of food for restaurants per the Health Regulations for Food Service Establishments §5-204; they must be sourced from a licensed food manufacturer. Additionally, if you prepare or offer meat products for resale to restaurants or stores you may need a license from the Vermont Agency of Agriculture.

Claiming an exemption from the licensing requirements does not exempt an establishment from compliance with the Department of Health's food safety and sanitation requirements in the <u>Good Manufacturing Practices for Food Rule (GMP)</u>, nor does the exemption prevent a public health inspector from inspecting your establishment to ensure those requirements are being complied with and investigating any potential health hazards.

Be prepared to submit documentation of a <u>Process Authority Review</u> as required in GMP Section 5.3.4 for low-acid canned foods, acidified foods and other foods that may pose a risk of biological hazards. A process authority review is a complete evaluation of how a food product is made, including all the steps of preparation, ingredients, and packaging, to ensure product safety. Exempt food manufacturers must also meet the general requirements for <u>Food Labeling for Vermont Producers and Processors</u>.
